CNY Services, Inc. is a private, not-for-profit behavioral health services organization dedicated to improving the quality of life for individuals and families affected by addictions, mental illness, and the many issues accompanying these challenges.

For over 20 years, CNY Services has served the most at-risk individuals throughout a four county region of Central New York.

The Forensic Case Management (FCM) team consists of trained case managers offering a broad range of experiences and service backgrounds. The mission of the FCM Program is to work with individuals recently released from jail / prison or those at significant risk of incarceration to address those factors that contribute to criminal recidivism—such as criminogenic behavioral factors, mental health, substance abuse, developmental disabilities, and poverty.

The FCM Program is a temporary linkage connecting program participants to community-based resources such as housing, employment training, and mental health and substance abuse services .



Forensic Case Management Program



Program Eligibility

Forensic Case Management services are specifically designed for individuals who are pending release or newly released from incarceration (county and state level) or those who are at imminent risk of incarceration (those being monitored by a specialized court or similar alternative to incarceration services) who do not have established case management services provided. FCM can work in partnership with probation and parole entities to give participants enhanced opportunities and access to community services that may prevent / reduce likelihood of criminal recidivism.

Services

Case Management Services include:

- ◆ Intake, Needs Assessment, and Service Planning
- ◆ Referral to appropriate community-based service providers. Case Managers may even attend appointments with participants as advocates and support resources.
- ◆ Encourage compliance with service regimens and monitor / communicate progress.
- ◆ Provide assistance with attaining resources from a variety of community agencies.



Referral to FCM Services

Referrals to FCM can be made for a variety of reasons:

- ◆ County or State incarceration facilities may refer to FCM as a part of discharge or re-entry service planning.
- ◆ Special-function court entities (such as drug courts or mental health courts) may refer as a means of assisting individuals who have demonstrated difficulties complying with mandates and are at imminent risk of incarceration.
- ◆ Community-based services entities that are working with individuals who have been recently released from incarceration and are demonstrating difficulties in life-management or daily activities of living.



How to Refer

- ◆ Contact the FCM Program and request a **referral form**. May be faxed to us or completed via telephone.
- ◆ To initiate the process, discharge planners from correctional facilities, hospitals, or other community-based service entities may send program information that may be used to assess appropriateness for referral.
